\_\_\_\_\_ Customer has been informed and understands that the TCL is a landfill and that vehicles are not intended to be driven on or around garbage and that damage to the Customer's vehicle may occur.

\_\_\_\_\_ Customer has been informed and understands that certain TCL roads or driveways may not be capable of sustaining the weight of a loaded Customer vehicle and that the vehicle may get damaged or stuck on TCL's property.

\_\_\_\_\_ Customer agrees to stay on the designated pathways as directed by TCL employees.

\_\_\_\_\_ Customer assumes the risk of loss to the property for any activities related to the Agreement; and Customer agrees to waive any and all claims for damages against TCL, except for damage intentionally caused by TCL.

\_\_\_\_\_ Customer understands and agrees that he/she will make no claim against TCL as a result of property damage caused by normal TCL operations.

\_\_\_\_\_ Customer may not deposit any hazardous wastes or substances in any container or location provided by TCL. Customer agrees to be liable for any and all costs TCL incurs directly or indirectly as a result of hazardous waste or substance deposited by Customer.\*\*

\_\_\_\_\_ Customer agrees to indemnify, defend, and hold harmless TCL, its employees, owners, and agents, from any loss, liability, damages, attorney fees, or expenses arising out of or related to this agreement, including any claims related to a hazardous waste or substance.

**Other Terms and Conditions**

1. The City of East Helena pays for you to dump 2000 pounds (\$39/ton) each fiscal year, beginning July 1st and ending June 30<sup>th</sup>. The 2000lbs **excludes** “extras” including mattresses, tires, tires on rims, refrigerant removal, or any other charges or fees charged by the landfill.
2. Payment for extras is due at the time of service.
3. Once you exceed 2000 pounds in the fiscal year, you will be responsible for paying for your own landfill use.
4. Open dumping hours are Monday – Saturday 7:00AM - 4:30PM.
5. Please follow all signs and directions upon entering the landfill.
6. Please present your dump pass to the scale operator upon entering, replacement dump passes can be created for a \$5.00 fee.
7. As you weigh out you will be required verify and confirm the weight and charge for your load by signing a copy of your ticket.
8. Over 2000 pounds will be billed monthly, due by the 20<sup>th</sup>. Past Due accounts will not be allowed to dump until paid and subject to late fees.
9. Returned Checks/ACH will result in a \$30.00 charge.
10. **You are dumping at your own risk. We are not responsible for injuries to your drivers, damage to your vehicles and/or property, etc. If you need assistance unloading your waste, we are not responsible for any damage or injury that may occur.**
